

Anti-Social Behaviour Summary

Newark and Sherwood Homes aims to deliver the best possible service for tenants and leaseholders who are experiencing anti – social behaviour.

This summary leaflet explains how we will deal with anti - social behaviour on our estates and within our communities.

We recognise that successfully tackling and reducing levels of anti - social behaviour within the district will help build sustainable and cohesive communities, making them stronger and safer for people to live in.

The Tenancy & Estate Team are responsible for estate management; including anti - social behaviour and all incidents of anti- social behaviour should be reported to them in the first instance.

What is Anti – Social Behaviour?

Anti - social behaviour can be defined as 'conduct capable of causing a nuisance or annoyance to any person'. This covers a whole range of behaviour and is outlined within the Tenancy Agreement as follows:-

You must not cause a nuisance, annoyance or disturbance to any other people. Examples of this would include, but are not limited to:

- loud music;
- persistent arguing;
- door slamming;
- dog barking or fouling;
- drunkenness;
- dumping rubbish;
- failing to control the behaviour of children;
- repairing vehicles;
- doing DIY at unreasonable hours;
- trespassing.

The Tenancy & Estate Team implement Newark and Sherwood Homes Anti - Social Behaviour Policy, when tackling anti - social behaviour on the estates throughout the district and will deal with the perpetrators in a timely and proportionate manner. If the perpetrators are tenants, living in properties managed by Newark and Sherwood Homes, then action can be taken by enforcing the conditions within the tenancy agreement, or for leaseholders under the terms of their lease.

This is not always a quick process and often involves the gathering of evidence over a period of time.

When the perpetrators are not tenants or leaseholders then alternative methods can be used. This often involves a multi agency approach with the Police, Newark and Sherwood District Council's Anti-Social Behaviour Team and legal support.

How can I report Anti-Social Behaviour?

We have the following methods that you can use:

In all cases of anti - social behaviour we work hard to maintain confidentiality. We also aim to provide support where the nature of the complaint leads to the alleged perpetrator working out who has made the complaint.

Tackling Anti-Social Behaviour at Newark and Sherwood Homes

Newark and Sherwood Homes will consider a variety of options when investigating allegations of anti - social behaviour.

As members of the Community Safety Partnership the adoption of a multi agency approach is one often used by Newark and Sherwood Homes. There are also a range of informal and formal actions that we can pursue.
